

## UPCOMING SEMINAR: "Data Privacy and the Internet"

IPLAC's Internet Law Committee, in collaboration with the Center for Intellectual Property Law & Information Technology (CIPLIT®), DePaul University College of Law, is pleased to sponsor a luncheon seminar on the topic of data privacy. In our technologically advanced world, significant amounts of data are available to us at our fingertips. What are the important issues related to data privacy, and what recent legislation and case law are crucial to the understanding of this topic? Katherine J. Strandburg, Associate Professor of Law at DePaul University College of Law, will give a summary presentation of this fascinating subject.

Katherine Strandburg teaches patent law, cyberlaw, trademark and copyright law, and information privacy law at DePaul. Since joining the DePaul faculty in 2002, she has published in the Wisconsin, Connecticut, and Rutgers law reviews, and the Berkeley Technology Law Journal. Professor Strandburg was the recipient of the College of Law's 2004 Award for Outstanding Achievement in Scholarship. She is co-editor of a recently published volume titled Privacy and Technologies of Identity: A Cross-Disciplinary Conversation, and was a faculty member for PLI's 2006 Privacy Law Institute (Seventh Annual): Evolving Laws and Practices in a Security-Driven World. Professor Strandburg obtained her law degree from the University of Chicago Law School with high honors in 1995, and served as a law clerk to the Hon. Richard D. Cudahy of the U.S. Court of Appeals for the Seventh Circuit.
